M.A./Ph.D.	China's Contemporary Political History	3	3	The course introduces students to political history of China since 1949. It emphasizes imperativeness of political changes in China and political force behind the transition.	
M.A./Ph.D.	China's External Relations	3	3	The course deals with China's external relations in the context of political science of international affairs. It focuses China's foreign affairs since 1949 and its influence on the global political order.	
M.A./Ph.D.	Seminar for China's Politics	3	3	Various issues of China's politics are dealt with in the courses in the perspective of comparative political analysis. Extensive discussions and paper presentations are vitalized in the class with guidance of instructor.	
M.A./Ph.D.	Contemporary Chinese Economic History	3	3	In the course China's quest for economic development since 1949 is dealt with intensively. Players, policies, and other source of economic changes are carefully analyzed in the class.	
M.A./Ph.D.	China's Economic System and Policy	3	3	The course is designed to introduce students to economic institutions and policies in China. Special attention directed towards linkages of policies, institutions, and economic performance.	
M.A./Ph.D.	China's External Economy	3	3	China's external trade and FDI as well as its role in the new global economic order are dealt with theoretically and practically in the course. It introduces students to the various topics related to China's external economy.	
M.A./Ph.D.	China's Industrial Economy	3	3	The course is introduces students to China's industrial structure and industrial policies, and its results, and some necessary theoretical tools are dealt with.	
M.A./Ph.D.	China's Business Management	3	3	Business management is one of the most exiting area of economic changes in China. In the course, features of state enterprises, private firms, and multinationals are analyzed in a comparative manner.
